Withersfield Parish Council

DRAFT Annual Accounts for 2017-18

This report summarises the income and expenditure for the year ending 31 March 2018. It outlines how the Parish Council has used the money entrusted to it for the benefit of the village and the parish.

It also outlines how the Parish Council intends to use the funds available to it during the current year.

Background:

The annual accounts of the Parish Council should be approved at the first Parish Council meeting following the end of the Financial Year. For Withersfield this is our meeting on 15th May.

Income has increased as the Council Tax precept has risen now that the Arboretum is fully occupied. In addition we have received a greater than anticipated income from the Graveyard which means that the costs of maintaining it (including grass cutting) has been covered by income this year.

We received two Locality Grant funds thanks to our County and Borough Councillors. £100 is funding yoga sessions under the Fit Villages scheme and £500 is contributing towards the cost of the new Parish notice board at the Arboretum.

The Sports Pavilion required reroofing this year and the Parish Council shared the costs with the Sports & Recreation committee. This was essential to maintain the integrity of the building.

The draft accounts have been passed to our internal auditor and any comments or observations will be reported to a Parish Council meeting.

Balances:

In previous years our auditors raised a concern at level of balances that the Parish Council was holding.

Although the balance at the end of 2017/18 has increased from £17,810 to £19,532, this includes earmarked reserves which have been committed during the 2017-18 year on Parish projects – provision of a new Noticeboard at the Arboretum, contribution towards the restoration of the War Memorial and a request for funding of Speedwatch signs. Taking these items into account our available reserves have 2017 the Parish Council decided to earmark £5,000 for maintenance of Parish assets. Taking this into account the available free assets have reduced to £12,509.

£690.83 from an award of £700 grant from the Community Transparency Fund was carried forward from 2016/17 and has been spent this year on funding a computer and printer for the use of the Parish Council clerk.
